HOW TO ENTER

- 1. Information on how to enter and the prize form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
- 2. Entry is only open to Australian NSW and QLD residents aged 18 years or over who reside in a postcode listed in the Annexure A below ("Eligible Entrant Postcodes").
